The following preambles and resolution were offered by Trustee Davis
and seconded by Trustee Bryant.

WHEREAS, Oakland Community College, State of Michigan (the "College") is a community college district organized and operating under Act 331, Public Acts of Michigan, 1966, as amended ("Act 331"); and

WHEREAS, under the provisions of Public Act 201 of 2012 the College receives State of Michigan appropriations; and

WHEREAS, the appropriation in PA 201 section 201(2)(cc) for local strategic value, as developed in cooperation with the Michigan Community College Association, shall be allocated to each community college; and

WHEREAS, one-third of funding available under the strategic value component shall be allocated to each category described in PA 201 Section 230 subsection (4); and

WHEREAS, the following categories of best practices reflect functional activities of community colleges that have strategic value to the local communities and regional economies: Category A, economic development and business or industry partnerships; Category B, educational partnerships; and Category C, community services.

NOW, THEREFORE, BE IT RESOLVED by the Oakland Community College Board of Trustees, State of Michigan, the Board certifies to the state budget director the College meets or exceeds at least four out of five best practices listed in each category described in PA 201(230)(4) in the following specific ways:

For Category A, Economic and Business or Industry Partnerships:

Economic and Business or Industry Partnerships	Examples of Oakland Community College Adherence
(i) The College has active partnerships with local employers including hospitals and health care providers.	The College has agreements across 14 different programs and agreements such as Health Administration, Nursing, Exercise Science with hospitals (including but not limited to Beaumont, Crittenton, Botsford, Oakwood and St. Joseph Hospital) and health care providers (such as HealthQuest Physical Therapy & Medical Fitness, Clawson). Economic Development partnerships (10) include groups such as Oakland County Economic Development Division, Oakland County Chambers Network, while Business and Industry partnerships (25) include groups such as Chrysler, GM, Eaton, and others.
(ii) The College provides customized on-site training for area companies, employees, or both.	The College has 16 current training agreements–5 pending approval; current contracts equal \$7.9 million. In addition, examples of classes offered include INCA (Chrysler), Ehooks (Chrysler), Leadership Series, PMP certification, Microsoft, LEAN, first aid, CPR, and hazardous communication.
(iii) The College supports entrepreneurship through a small business assistance center or other training or consulting activities targeted toward small businesses.	The College provides lead faculty in engaging with the Goldman Sachs 10,000 Small Businesses initiative in partnership with Detroit area economic developers. In addition, OCC is subcontracting with Wayne State University to provide instruction and recruitment to support small businesses.
(iv) The College supports technological advancement through industry partnerships, incubation activities, or operation of a Michigan technical education center or other advanced technology center.	The College operates a Michigan Technical Education Center (M-TEC) in Auburn Hills specializing in the delivery of Information Technology training and certification.

<p>(v) The College has active partnerships with local or regional workforce and economic development agencies.</p>	<p>The College is an active partner in the Workforce Intelligence Network (WIN) of Southeast Michigan, Michigan New Jobs Training (MNJT) Fund and Skilled Trades Training Fund in collaboration with Oakland County and Oakland County Michigan Works! Economic Development partnerships (10) include groups such as Oakland County Economic Development Division, Oakland County Chambers Network, Automation Alley, and MMTC.</p>

For Category B, Educational Partnerships:

<p>Educational Partnerships</p>	<p>Examples of Oakland Community College Adherence</p>
<p>(i) The College has active partnerships with regional high schools, intermediate school districts, and career-tech centers to provide instruction through dual enrollment, direct credit, middle college, or academy programs.</p>	<p>Under the statewide articulation model, the College has 272 active agreements with 47 Michigan school districts and technical centers covering 15 OCC courses. In addition, the College also has started Oakland Technical Early College with Oakland Schools, Oakland Early College, a schools of choice program through the West Bloomfield School District, and Oakland ACE (Accelerated College Experience), an early college program through Oakland Schools for students in participating Oakland County districts. Additionally, the Auburn Hills Campus collaborated and supported 25-30 dual-enrolled high school students from the Pontiac School District including Pontiac High School and the International Tech Academy. The Southfield Campus also hosted the University High School Dual Enrollment Program during the fall and winter semesters.</p>
<p>(ii) The College hosts, sponsors, or participates in enrichment programs for area K-12 students, such as college days, summer or after-school programming, or science Olympiad.</p>	<p>The Man Up Program combines Dual Enrollment and intense personal interaction with OCC faculty and staff designed to improve the college success rate of African American young men. Approximately 40 participants attend from the Birmingham, Hazel Park, Oak Park and Southfield school districts. The College also is an active participant in Manufacturing Day, which provides high school students the opportunity to experience careers in advanced manufacturing.</p>

<p>(iii) The College provides, supports or participates in programming to promote successful transitions to college for traditional age students, including grant programs such as talent search, upward bound, or other activities to promote college readiness in area high schools and community centers.</p>	<p>Campus recruitment partnerships with area high schools provided high school seniors the opportunity to tour campuses and learn about services and programs from various department representatives, including Counseling and ACCESS. Additionally, Mandatory New Student Orientations were held for students at highest risk of dropping out, specifically those high school students or returning adult learners that place into developmental English.</p>
<p>(iv) The College provides, supports, or participates in programming to promote successful transitions to college for new or reentering adult students, such as adult basic education, GED preparation, GED testing, or recruiting, advising, or orientation activities specific to adults.</p>	<p>To date, under the auspices of a grant from Oakland County Workforce Development Division, OCC has provided PowerPath screening and resources for over 3,500 Michigan Works! program participants. In addition, OCC has formed partnerships with Oakland County Adult Education programs, and includes the GED test as one of the test offerings in the OCC M-TEC Testing Center.</p>
<p>(v) The College has active partnerships with regional 4-year colleges and universities to promote successful transfer, such as articulation, 2+2, or reverse transfer agreements or operation of a university center.</p>	<p>The College has 263 active agreements with 28 post-secondary institutions in Michigan and other states, including 243 articulation agreements, one consortium agreement, six reciprocal-joint programming agreements with Macomb Community College and six Institutional Partnership Agreements/Memorandums of Understanding. Three of the seven reverse transfer agreements are with the institutions where the majority of our students transfer – Oakland University, Wayne State University and Walsh College. Additionally, the College offers College-wide transfer days to U of M-Ann Arbor, taking students, managers and administrators to the University for personalized student assessments and tours. U of M-Dearborn provided in-kind donations for the 2016 College-wide Leadership Summit, where the University recruiter also spoke to students about scholarship and transfer.</p>

For Category C, Community Services:

Community Services	Examples of Oakland Community College Adherence
(i) The College provides continuing education programming for leisure, wellness, personal enrichment, or professional development.	The College offers continuing education courses including fencing, culinary studies, writing and publishing; and professional education courses including business finance, computer networking, grant writing, Motorcycle Safety and project management.
(ii) The College operates or sponsors opportunities for community members to engage in activities that promote leisure, wellness, cultural or personal enrichment such as community sports teams, theater or musical ensembles, or artist guilds.	The College offers a myriad of community engagement opportunities including sponsorship of the Pontiac Fine Arts Camp; The Brooksie Way Half Marathon, 10K and 5K Event; Child ID event offering free fingerprint and DNA ID kits and a family fun day; and Swing dance/concert for the Fallen and Wounded Soldiers Fund.
(iii) The College operates public facilities to promote cultural, educational, or personal enrichment for community members, such as libraries, computer labs, performing arts centers, museums, art galleries, or television or radio stations.	The College operates public facilities including libraries, computer labs, theaters, and art exhibits. Internal departments and community organizations utilize the Smith Theater for various functions such as enrichment classes, concerts, and two plays per year among other theater productions. Additional examples of community events include the Martin Luther King Jr. Convocation, Ann Arbor Film Festival, Michigan Classic Ballet Company, and the Korean American Cultural Center of Michigan.
(iv) The College operates public facilities to promote leisure or wellness activities for community members, including gymnasiums, athletic fields, tennis courts, fitness centers, hiking or biking trails, or natural areas.	The College operates public facilities including gymnasiums, tennis courts, weightlifting facilities, and hiking trails in natural areas.
(v) The College promotes, sponsors, or hosts community service activities for students, staff or community members.	The Student Success Fund (SSF) provides financial assistance to OCC students who face a serious need which threatens their educational goals. As part of the SSF, the <i>Share to Care initiative</i> , which started at the Royal Oak and Southfield Campus, provides gift cards to students in need of immediate assistance. The College

	<p>Phi Theta Kappa Honors Society, under the direction of Student LIFE, participates in the annual Relay For Life event at West Bloomfield High School. In addition community members participated in the Poverty Simulation; the annual Diversity and Inclusion Fair which included a "human library," where community members volunteer to talk with students and other attendees about their lives that have been fraught with adversity and prejudice; dental screenings; mental health screenings; food and clothing drives; Miracle Boxes for deployed troops; electronic waste collection events; blood drives and voter registration events.</p>
