



DEPENDENT Verification Form 2017 - 2018

Your financial aid application was selected for review in a process called verification. In this process we will be comparing information from your FAFSA to your and your parent(s) 2015 Federal tax information. Under the financial aid program rules (CFR Title 34, Part 668), the college has the right and obligation to ask you for this information before we can award you financial aid. We cannot process your financial aid application without these documents.

What you need to do:

1. Complete this worksheet.
2. Submit the completed worksheet to the Office of Financial Aid. If the student or parent(s) is unable to use the IRS Data Retrieval Tool in FAFSA on the Web, an official 2015 IRS tax return transcript may be submitted. To obtain an IRS tax return transcript, call 1-800-908-9946, or obtain one online at www.IRS.gov. Under "Tools," select "Get Transcript of Your Tax Records." You may either retrieve the transcript online or elect to have it mailed to your home address. Make sure you request the "Tax **Return** Transcript," **not** the Account Transcript.
3. You may submit a copy of your 2015 tax return. If you did not keep a copy of your tax return, request a copy from your tax preparer or request a copy from the Internal Revenue Service (IRS).
